Liability Insurance: All vendors must be covered by liability insurance. An insurance rider which states the following: **“Rondele Ranch LLC, their officers, agents & employees to be named as additionally insured.”** This certificate must be received with the application.

Electrical Needs: Rondele Ranch will not be supply electricity to vendors. You must supply your own generator or alternate power supply.

- Access for set-up starting at 10 a.m. on Saturday, June 28, 2025. Gates open at 3:30 pm.
- Teardown can be done immediately when the fireworks start, but no later than 9 a.m. on Sunday, June 29. Vendors are encouraged to teardown and enjoy the fireworks display!
- Vendor booth fee is due upon acceptance for selling their goods (vendors may not sell any liquor or soda). Water may be sold by the vendor. In exchange for selling goods, Rondele Ranch will not charge a percentage of their profits.
- Electricity is not available from Rondele Ranch; you will need to provide your own generator.
- Rondele Ranch will be advertising event along with the names of the vendors selling goods without any cost to the vendor.
- Rondele Ranch will provide each vendor with flyers to display at their business or hand out.
- All garbage must be removed by vendor, any excess clean-up needed, Rondele will charge for liter/trash removal/cleanup.
- We expect professionalism when on Rondele Ranch property as you will be representing Rondele Ranch during our community event!
